

INFORMATION FROM THE MWF UNIFORM RULES CHAIR, BOB MILLER

For competition the following information has been added to the LAPIDARY MATERIALS NAMES LIST. There will not be time to publish this before this year's show into a supplement for the uniform rules book. This is a necessary guide for anyone who enters opal into competition.

OPAL (DOUBLET) or OPAL, DOUBLET IDAHO

OPAL (TRIPLET) or OPAL, TRIPLET IDAHO

The word doublet or triplet MUST be on the label and WILL BE

JUDGED. Parentheses may or may not be used.

SOME INTERESTING NEWS ABOUT COLLECTING IN THE U.S. VIA CANADA (editor via MWF Newsletter)

Chuck Collins, the Midwest Federation liaison to the Central Canadian Federation, had some interesting tidbits to report from his perusal of Canadian federation newsletters.

Did you know that it is illegal to collect at ROAD CUTS in the state of VERMONT? Violators caught be the police will be ticketed.

In UTAH it is required that you carry a "valid, current rock club membership card when you are collecting on State Education lands (all state owned lands) or be subject to a fine for picking up rock without obtaining proper permits. The Utah Federation has an agreement with the government and pays an annual \$200 fee to allow hobby collecting on these lands."

If you plan to collect obsidian in designated area of Modoc National Forest in Northern California, you must obtain a permit for non-commercial recreational rockhounding by writing to: Minerals Officer, Warner Mountain Ranger District, 385 Wallace St., Cedarville CA 96104.

MORE FIELD TRIP NEWS — June King, MWF Safety & Field trips On a recent cold, snowy field trip to Duff Quarry, Huntsville, Ohio our group was informed that the quarry will soon start blasting at a lower level. Each layer can mean a different selection of minerals and it could mean we will not collect the special pyrite in the near future.

MICHIGAN MINE YIELDS 2.1 BILLION YEAR OLD FOSSILS--Joyce Hanschu, MWF Education Chairman

Hundreds of 2.1 billion year old fossils have been found in the Negaunee Iron Formation at the Empire Mine near Marquette, MI. A few of these fossils were discovered in float material in 1974 by Tsu-Ming Han, Senior Research Scientist for Cleveland-Cliffs Mining Co. Serious study of the fossils began in 1990 when many more were found in place in the mine.

These Michigan fossils, <u>Grypania</u> cf <u>G. spiralis</u>, are 700 to 1000 million years older than <u>Grypania spiralis</u>, which they closly resemble... This is significant because it indicates that complex marine plants lived much earlier than previously thought. Until now, <u>Gypania spiralis</u> had only been found in rocks 1.3 to 1.4 billion years old in China, India and Montana.

The Michigan <u>Grypania</u> are found in two different types: thick spirally coiled filaments 1.5 mm in diameter and thin spirally coiled filaments 0.7 to 1.1 mm in diameter. Both can be up to 90mm in length. Both are thought to be the remains of multicelled, photosynthetic algaie deposited in a shallow water environment. Studies are continuing to learn more about these fossils.

EPOXY HINT via Rockpile 1/94 via Pegmatite & Petrograph After a tube of epoxy has been opened, dp a bit of Vaseline on the threads. Also, put some Vaseline around the rim of your tumbler before bolting on the lid. It makes a tighter seal and it will be easy to revove the lid.

ahall Mining Bill Released from Committee

HR-322 sponsored by Congressman Nick J. Rahall, II (D-WV) was reported out of house committee on November 3, 1993. I suspect that by the time this newsletter reaches your mailbox the Rahall mining bill will have been voted upon and passed by the U.S. House of Representatives. It will then go to a House-Senate conterence committee where an attempt will be made to reconcile it with S-775 sponsored by Senator Larry E. Craig (R-ID) which has already passed the Senate. The House conferees would be appointed by Congressman George Miller (D-CA) and the Senate conferees would be appointed by Senator J. Bennet Johnson (D-LA).

Our interest in this legislation is essentially two-fold. First, a number of clubs and individual collectors have operated mining claims for the purpose of recovering specimen material. Second, a number of mines are also operated commercially for the sole purpose of recovering specimen material, e.g. the Sweet Home Mine operated by Brian Lees and associates.

With reference to HR-322, my predecessor John Boland wrote in the May 1993 AFMS Newsletter, "although these bills were written to extract royalties from the big mining companies, it could destroy the small mining operator who is a major supplier of hobby materials, and close down club and societies mining claims that are used for recreational purposes."

In contrast, the American Lands Access Association (ALAA) has described S-775 as a "compromise bill" that the mining industry and hobbyists "can live with." If HR-322 has not yet passed the full house, please write your Congressman. If HR-322 has reached the Senate-House conference committee, please write Congressman George Miller and Senator Johnson to express your views.

The Paleontology Legislation

As of this writing, neither the newly redratted bill of Senator Max Baucus (D-MT) nor the ALAA drafted legislation has been introduced. We are advised by the staff of Congressman Tim Johnson (D-SD) that they are actively lobbying members of the House Natural Resources Committee and the National Parks, Forests and Public Lands Subcommittee in an attempt to reach a consensus as to the appropriateness of the legislation. We have been assured by Congressman Johnson's staff that they will push forward with this proposed legislation. We are advised that Congressman Joe Skeen (R-NM) and his staff have been working with Congressman Johnson's office to promote the ALAA drafted legislation. Please write to encourage their efforts, especially if you reside in the district of either of these Congressmen.

The California Desert Protection Act of 1993

S-21 introduced by Senator Feinstein (D-CA) was reported out upon by the full Senate in the near future. HR-518 spon-

sored by Congression Richard H. Lehman (D-CA) has been the subject of one House committee hearing but, as of this writing, no action by the House committee is pending or scheduled. I hope to obtain a copy of S-21 as amended and report on the amendments in the next AFMS Newsletter.
